## Definitions

Service

- Service is the <u>https://flatmate.ai</u> website and the <u>https://dashboard.flatmate.ai</u> website operated by Rushmore s. r. o.

#### Personal Data

- Personal Data means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

#### Usage Data

- Usage Data is data collected automatically either generated using the Service or from the Service infrastructure itself (for example, the duration of a page visit).

#### Cookies

- Cookies are small files stored on your device (computer or mobile device).

Data Controller

- Data Controller means the natural or legal person who (either alone or jointly or in common with other persons) determines the purposes for which and the way any personal information are, or are to be, processed. For this Privacy Policy, we are a Data Controller of your Personal Data.

#### Information Collection and Use

We collect several different types of information for various purposes to provide and improve our Service to you.

Types of Data collected.

Personal Data

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

- Email address
- Your IP Address
- Cookies and Usage data

We may use your Personal Data to contact you with newsletters, marketing or promotional materials and other information that may be of interest to you. You may opt out of receiving any, or all, of these communications from us by contacting us.

#### Usage Data

We may also collect information on how the Service is accessed and used ("Usage Data"). Tracking and Cookies Data

Cookies are files with a small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Other tracking technologies are also used such as beacons, tags and scripts to collect and track information and to improve and analyze our Service.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Service.

Examples of Cookies we use:

- Session Cookies. We use Session Cookies to keep you logged in on our site. We also use Google Analytics, which uses cookies for general statistical data to help us learn and grow about how to make a better user experience.

#### Use of Data

# Legal Basis for Processing Personal Data under the General Data Protection Regulation (GDPR)

Flatmate may process your Personal Data because:

## Retention of Data
